I. FUNDING OPPORTUNITY DESCRIPTION

A. Program Description

Applications for the Bone Marrow Failure Research Program (BMFRP) are being solicited by the Assistant Secretary of Defense for Health Affairs, Defense Health Program. The BMFRP was established in fiscal year 2008 (FY08) to promote innovative research focused on bone marrow failure (BMF). Appropriations for the BMFRP from FY08 through FY11 totaled \$13.75 million (M). The FY12 appropriation is \$3.2M.

The vision of the BMFRP is to understand and cure BMF diseases. Toward that end, the program challenges the scientific community to design innovative research that will advance the understanding of inherited and acquired BMF diseases to improve the health and life of individuals living with these diseases, with the ultimate goals of prevention and/or cure.

FY12 BMFRP Objective: The objective of the BMFRP is to fund scientifically meritorious research focused on BMF syndromes and their long-term sequelae. Investigator-initiated research is encouraged in the areas of congenital or acquired BMF. Studies focused on BMF syndromes and their progression to other malignancies such as leukemia, are acceptable. *However, research primarily focused on myeloproliferative neoplasms, leukemia, or other malignancies is discouraged.* Translational projects including bone marrow transplantation studies are encouraged to address issues that are unique to BMF syndromes. Stem cell biology studies should be clearly related to BMF syndromes.

B. Award Information

The BMFRP Idea Award is intended to support innovative ideas and high-impact approaches to BMF research to move toward the BMFRP vision of understanding and curing BMF diseases. This award mechanism is designed to support new ideas, not ideas that are extensions of existing work. Proposed research studies should have a high probability of revealing new avenues of investigation. Research projects should include a well-formulated, testable hypothesis based on strong scientific rationale.

The following are significant features of this award mechanism:

- 1. Innovation:** Innovative research may introduce a new paradigm, challenge existing paradigms, look at existing problems from new perspectives, or exhibit other uniquely creative qualities. This may include high-risk, potentially high-gain, approaches to BMF research, provided that there is the potential for significant impact on the field of research, and/or patient care and/or quality of life. Research that is merely an incremental advance is not considered innovative and will not be considered for funding under this award mechanism.
- 2. Impact:** Proposed research projects should address a central critical issue or question in BMF research. High-impact research will, if successful, significantly advance current methods and concepts for the prevention, detection, diagnosis, and/or treatment of BMF.

- 3. Preliminary Data:** Preliminary data such as unpublished results from the laboratory of the Principal Investigator (PI) or collaborators named on this application and/or data from the published literature relevant to BMF and the proposed research project should be included.

Use of Human Subjects and Human Anatomical Substances: All Department of Defense (DoD)-funded research projects (new and ongoing) involving human subjects and human anatomical substances must be reviewed and approved by the U.S. Army Medical Research and Materiel Command (USAMRMC) Office of Research Protections (ORP), Human Research Protection Office (HRPO), and the local Institutional Review Board of record. The HRPO is mandated to comply with specific laws and directives governing all research involving human subjects that is conducted or supported by the DoD. Refer to General Application Instructions, Appendix 5, for general regulatory requirements. ***Clinical trials are not allowed.*** A clinical trial is defined as a prospective accrual of patients where an intervention (e.g., device, drug, biologic, surgical procedure, rehabilitative modality, behavioral intervention, or other) is tested on a human subject for a measurable outcome with respect to exploratory information, safety, effectiveness, and/or efficacy. This outcome represents a direct effect on the subject of that intervention or interaction. The FY12 BMFRP is not offering an award mechanism that will support clinical trials; PIs requesting funding for a clinical trial are encouraged to investigate other funding agencies for support. The Congressionally Directed Medical Research Programs (CDMRP) intends that data and research resources generated by CDMRP-funded research activities be made available to the research community (which includes both scientific and consumer advocacy communities) and to the public at large. For additional guidance, refer to the General Application Instructions, Appendix 4, Section K.

C. Eligibility Information

- Investigators at or above the level of an Assistant Professor (or equivalent) are eligible to submit applications.
- Cost sharing/matching is not an eligibility requirement.
- Refer to the General Application Instructions, Appendix 1, for general eligibility information.

D. Funding

- The maximum period of performance is **3** years.
- The maximum allowable direct costs for the entire period of performance are **\$360,000** plus indirect costs.
- All direct and indirect costs of any subaward (subgrant or subcontract) must be included in the total direct costs of the primary award.

- The applicant may request the entire maximum funding amount for a project that may have a period of performance less than the maximum 3 years.
- Regardless of the period of performance proposed, the applicant may not exceed the maximum allowable direct costs. Indirect costs shall be proposed in accordance with the organization's negotiated rate agreement.

Refer to the General Application Instructions, Section II.C., for budget regulations and instructions for the Research & Related Budget. In addition, for this award mechanism, direct costs:

May be requested for (not all-inclusive):

- Salary
- Research supplies
- Clinical research costs (*This award may not be used to conduct clinical trials.*)
- Equipment
- Support for multidisciplinary collaborations
- Travel between collaborating organizations
- Travel costs of up to \$1,800 per year to attend scientific/technical meetings

The CDMRP expects to allot approximately \$2.3M of the \$3.2M FY12 BMFRP appropriation to fund approximately four Idea Award applications, depending on the quality and number of applications received. Funding of applications received in response to this Program Announcement/Funding Opportunity is contingent upon the availability of Federal funds for this program.

II. SUBMISSION INFORMATION

Submission is a multi-step process requiring both (1) pre-application submission through the CDMRP eReceipt System (<https://cdmrp.org/>) and (2) application submission through Grants.gov (<http://www.grants.gov/>).

Submission of the same research project to different funding opportunities within the same program and fiscal year is prohibited. The Government will reject duplicative applications.

A. Where to Obtain the Application Package

To obtain the complete application package, including all required forms, perform a Grants.gov (<http://www.grants.gov/>) basic search using the Funding Opportunity Number: W81XWH-12-BMFRP-IA.

B. Pre-Application Submission Content and Form

All pre-application components must be submitted by the PI through the CDMRP eReceipt System (<https://cdmrp.org/>). Because the invitation to submit an application is based on the

contents of the pre-application, investigators should not change the title or research objectives after the pre-application is submitted.

PIs and organizations identified in the application should be the same as those identified in the pre-application. If any changes are necessary after submission of the pre-application, the PI must contact the CDMRP Help Desk at help@cdmrp.org or 1-301-682-5507.

A change in PI or organization after submission of the pre-application will be allowed only at the discretion of the U.S. Army Medical Research Acquisition Activity (USAMRAA) Contracting/Grants Officer.

The pre-application consists of the following components, which are organized in the CDMRP eReceipt System by separate tabs (refer to the General Application Instructions, Section II.B., for additional information on pre-application submission):

- **Collaborators and Conflicts of Interest (COI) – Tab 3**

FY12 BMFRP Integration Panel (IP) members should not be involved in any pre-application or application. For questions related to IP members and pre-applications or applications, refer to Section IV.C., Withdrawal, or contact the CDMRP Help Desk at help@cdmrp.org or 1-301-682-5507.

- **Required Files – Tab 4**

Preproposal Narrative (two-page limit): The Preproposal Narrative page limit applies to text and any figures, tables, graphs, photographs, diagrams, chemical structures, pictures, pictorials, and cartoons.

The Preproposal Narrative should include the following:

- **Rationale:** Clearly articulate the rationale for the project by presenting the ideas and reasoning behind the proposed research. Describe how the proposed research adheres to the intent of the program.
- **Hypothesis or Objective:** State the hypothesis to be tested or the objective to be reached. Clearly articulate how the research examines the objectives of the BMFRP. State the project's specific aims.
- **Innovation:** Describe how the proposed research is innovative and how the research represents more than an incremental advance on published data.
- **Impact:** Explain the potential impact of the proposed research project and how it will, if successful, move the research field toward achieving the BMFRP's vision to understand and cure BMF diseases.

Pre-Application Supporting Documentation: The items to be included as supporting documentation for the pre-application are limited to:

- **References Cited (one-page limit):** List the references cited (including URLs if available) in the preproposal narrative using a standard reference format that includes the full citation (i.e., author[s], year published, title of reference, source of reference, volume, chapter, page numbers, and publisher, as appropriate).

- **List of Abbreviations, Acronyms, and Symbols:** Provide a list of abbreviations, acronyms, and symbols.
- **Key Personnel Biographical Sketches (four-page limit per individual):** Include biographical sketches for the PI and other key collaborators.
- **Submit Pre-Application – Tab 5**
This tab must be completed for the pre-application to be accepted and processed by the CDMRP.
- **Other Documents Tab**
No additional documents are required.

Pre-Application Screening

- **Pre-Application Screening Criteria**
To determine the technical merits of the pre-application and the relevance to the mission of the DoD and the BMFRP, pre-applications will be screened by the BMFRP IP based on the following criteria:
 - **Adherence to the intent of the award mechanism**
 - **Research Idea:** How well the proposed project addresses a central critical problem or question in BMF research. How well the proposed research focuses on FY12 BMFRP objectives.
 - **Innovation:** How well the research proposes new paradigms, challenges existing paradigms, looks at existing problems from new perspectives, or exhibits other uniquely creative qualities.
 - **Impact:** To what degree the proposed research, if successful, will make an important contribution that significantly advances current methods and concepts toward the BMFRP vision of understanding and curing BMF diseases.
 - **Principal Investigator**
 - Whether the PI meets the eligibility requirements.
 - To what degree the PI and research team’s backgrounds and BMF-related expertise are appropriate to successfully address the proposed research idea.
- **Notification of Pre-Application Screening Results**
Following the pre-application screening, PIs will be notified as to whether or not they are invited to submit applications; however, they will not receive feedback (e.g., a critique of strengths and weaknesses) on their pre-application.

Pre-application notification dates are indicated on the [title page](#) of this Program Announcement/Funding Opportunity.

C. Application Submission Content and Form

Applications will not be accepted unless the PI has received notification of invitation.

Each application submission must include the completed application package of forms and attachments provided in Grants.gov for this Program Announcement/Funding Opportunity. The application package is submitted by the Authorized Organizational Representative through the Grants.gov portal (<http://www.grants.gov/>).

Grants.gov application package components: For the BMFRP Idea Award, the Grants.gov application package includes the following components (refer to the General Application Instructions, Section II.C., for additional information on application submission):

1. SF 424 (R&R) Application for Federal Assistance Form: Refer to the General Application Instructions, Section II.C., for detailed information.

2. Attachments Form

- **Attachment 1: Project Narrative (eight-page limit):** Upload as “ProjectNarrative.pdf.”

Describe the proposed project in detail using the outline below.

- **Background:** Present the ideas and reasoning behind the proposed research. Describe previous experience most pertinent to this application. Preliminary data such as unpublished results from the laboratory of the PI or collaborators named on this application and/or data from the published literature relevant to the proposed research project should be included.
- **Hypothesis or Objective:** State the hypothesis to be tested or the objective to be reached.
- **Specific Aims:** Concisely explain the project’s specific aims. If this research project is part of a larger study, present only the tasks that the DoD award would fund.
- **Research Strategy:** Describe the experimental design, methods, and analyses, including appropriate controls and statistical plan, in sufficient detail for evaluation. Include specific examples of innovative elements incorporated into the research design. Address potential problem areas and present alternative methods and approaches. If human subjects or human anatomical samples will be used, include a plan for the recruitment of subjects or the acquisition of samples and document the experience of the PI and/or key collaborators in recruiting human subjects for similar projects. *This award may not be used to conduct clinical trials.*

- **Attachment 2: Supporting Documentation.** Start each document on a new page. Combine and upload as a single file named “Support.pdf.” If documents are scanned to pdf, the lowest resolution (100 to 150 dpi) should be used. *There are no page limits for any component unless otherwise noted. Include only those components described below; inclusion of items not requested may result in administrative rejection of the application.*
 - References Cited: List the references cited (including URLs if available) in the project narrative using a standard reference format that includes the full citation (i.e., author[s], year published, title of reference, source of reference, volume, chapter, page numbers, and publisher, as appropriate).
 - List of Abbreviations, Acronyms, and Symbols: Provide a list of abbreviations, acronyms, and symbols.
 - Facilities, Existing Equipment, and Other Resources: Describe the facilities and equipment available for performance of the proposed project and any additional facilities or equipment proposed for acquisition at no cost to the award. Indicate if Government-owned facilities or equipment are proposed for use. Reference should be made to the original or present award under which the facilities or equipment items are now accountable. There is no form for this information.
 - Publications and/or Patent Abstracts (five-document limit): Include relevant publication URLs and/or patent abstracts. If publications are not publicly available, then a copy/copies of the published manuscript(s) must be included in Attachment 2. Extra items will not be reviewed.
 - Letters of Organizational Support: Provide a letter (or letters, if applicable), signed by the Department Chair or appropriate organization official, reflecting the laboratory space, equipment, and other resources available for the project.
 - Letters of Collaboration (if applicable): Provide a signed letter from each collaborating individual or organization that will demonstrate that the PI has the support or resources necessary for the proposed work.
 - Intellectual and Material Property Plan (if applicable): Provide a plan for resolving intellectual and material property issues among participating organizations.
- **Attachment 3: Technical Abstract (one-page limit):** Upload as “TechAbs.pdf.” Describe the proposed research project including the following elements: background, hypothesis or objectives, study design, innovative aspects of the proposed research project, and potential impact of the anticipated research results. The technical abstract is used by all reviewers; however, programmatic reviewers do not have access to the full application and rely on the technical abstract for appropriate description of the project’s key aspects.

- **Attachment 4: Lay Abstract (one-page limit):** Upload as “LayAbs.pdf.”

Include an overview of the proposed research project that can be readily understood by lay persons. Clearly describe the central critical problem or question to be addressed by the proposed research project, the innovative aspect of the research, and the impact that the project results might have on the field of BMF research and/or patient care. Do not duplicate the technical abstract.

The lay abstract is used by lay peer reviewers along with other components of the application package. Programmatic reviewers do not have access to the full application and rely on the lay abstract for appropriate description of the project’s key aspects.
- **Attachment 5: Statement of Work (SOW) (three-page limit):** Upload as “SOW.pdf.” Refer to the General Application Instructions, Section II.C., for detailed information.
- **Attachment 6: Impact Statement (one-page limit):** Upload as “Impact.pdf.”

Describe why the proposed research project is important to understanding the causes and progression of BMF and/or to realizing improvements in patient care and/or quality of life.

Describe the short-term impact: Detail the anticipated outcome(s)/product(s) (intellectual and/or tangible) that will be directly attributed to the results of the proposed research.

Describe the long-term impact: Explain the potential long-term impact of this study on the field of research and/or patient care. Describe the anticipated long-term gains from this research course and compare these to BMF information/products currently available, if applicable.
- **Attachment 7: Innovation Statement (one-page limit):** Upload as “Innovation.pdf.”

Summarize how the proposed work is innovative. Investigating the next logical step or an incremental advancement on published data is not considered innovative.

Although not all-inclusive, the following examples are ways in which proposed work may be innovative; these examples are intended to help PIs frame the innovative features of the research proposed:

 - Study concept – Investigation of a novel idea and/or research question.
 - Research method or technology – Use of novel research methods or new technologies, including technology development, to address a research question.
 - Novel method or technology – Development of a novel method or technology for prevention, detection, diagnosis, or treatment.
 - Existing methods or technologies – Application or adaptation of existing methods or technologies for novel research or clinical purposes, or for research or clinical purposes that differ fundamentally from those originally intended.

- 3. Research & Related Senior/Key Person Profile (Expanded):** Refer to the General Application Instructions, Section II.C., for detailed information.
 - PI Biographical Sketch (four-page limit): Upload as “Biosketch_LastName.pdf.”
 - PI Current/Pending Support (no page limit): Upload as “Support_LastName.pdf.”
 - Key Personnel Biographical Sketches (four-page limit each): Upload as “Biosketch_LastName.pdf.”
 - Key Personnel Current/Pending Support (no page limit): Upload as “Support_LastName.pdf.”
- 4. Research & Related Budget:** Refer to the General Application Instructions, Section II.C., for detailed information.
 - Budget Justification (no page limit): Upload as “BudgetJustification.pdf.”
- 5. Project/Performance Site Location(s) Form:** Refer to the General Application Instructions, Section II.C., for detailed information.
- 6. R & R Subaward Budget Attachment(s) Form (if applicable):** Refer to the General Application Instructions, Section II.C., for detailed information.

D. Submission Dates and Times

All submission dates and times are indicated on the [title page](#) of this Program Announcement/Funding Opportunity. Pre-application and application submissions are required. Failure to meet any one of the deadlines will result in application rejection.

E. Other Submission Requirements

Refer to the General Application Instructions, Appendix 2, for detailed formatting guidelines.

All applications must be submitted through Grants.gov. Organizations are required to provide a Data Universal Number System (DUNS) number and register with the Central Contractor Registry (CCR) to submit applications through the Grants.gov portal. Refer to the General Application Instructions, Appendix 3, for information on Grants.gov requirements.

III. APPLICATION REVIEW INFORMATION

A. Application Review and Selection Process

All applications are evaluated by scientists, clinicians, and consumer advocates using a two-tier review process. The first tier is a peer review of applications against established criteria for determining technical merit. The second tier is a programmatic review that compares applications to each other and makes recommendations for funding to the Commanding General, U.S. Army Medical Research and Materiel Command (USAMRMC), based on technical merit, the relevance to the mission of the (DoD) and BMFRP, and the specific intent of the award mechanism. The highest-scoring applications from the first tier of review are not automatically

recommended for funding. Additional information about the two-tier review process used by the CDMRP can be found at <http://cdmrp.army.mil/about/fundingprocess.shtml>.

All CDMRP review processes are conducted confidentially to maintain the integrity of the merit-based selection process. Each level of review requires panelists to sign a non-disclosure statement attesting that application and evaluation information will not be disclosed outside the panel. Violations of the non-disclosure statement can result in the dissolving of a panel(s) and other corrective actions. Organizational personnel and PIs are prohibited from contacting persons involved in the review process to gain protected evaluation information or to influence the evaluation process. Violations of these prohibitions will result in the administrative withdrawal of the organization's application. Violations by panelists or PIs that compromise the confidentiality of the review process may also result in suspension or debarment of their employing organizations from Federal awards. Furthermore, the unauthorized disclosure of confidential information of one party to another third party is a crime in accordance with Title 18 United States Code 1905.

B. Application Review Criteria

1. Peer Review: To determine technical merit, all applications will be evaluated according to the following scored criteria, which are of equal importance:

- **Impact**

- How the research project, if successful, will make an important contribution that significantly advances our understanding of the causes and the progression of BMF and/or improves the patient care and/or quality of life.
- How well the anticipated short-term outcome(s)/product(s) (intellectual and/or tangible) are described.
- How well the anticipated long-term gains from this research course are described and compared to information/products currently available, if applicable.

- **Innovation**

- How well the research proposes new paradigms or challenges existing paradigms in one or more of the following ways: concept or question, research methods or technologies, adaptations of existing methods or technologies, or other ways.
- How the proposed research project is a new research idea and not the next logical step or continuation of a previous research project.
- How the proposed research represents more than an incremental advance upon published data.

- **Research Strategy and Feasibility**

- How the scientific rationale supports the project and its feasibility, as demonstrated by a critical review and analysis of the literature, BMF-relevant preliminary data, or logical reasoning.

- How well the hypotheses or objectives, specific aims, experimental design, methods, and analyses are developed and integrated into the project.
- How well the PI identifies potential problems and addresses alternative approaches.
- Whether the application includes an appropriate statistical plan with power analysis, if applicable.

In addition, the following unscored criteria will also contribute to the overall evaluation of the application:

- **Personnel**
 - Whether the BMF-related expertise represented on the research team is appropriate to accomplish the proposed work.
 - To what degree the levels of effort are appropriate for successful conduct of the proposed work.
- **Environment**
 - How the scientific environment is appropriate for the proposed research.
 - How the research requirements are supported by the availability of and accessibility to facilities and resources (including collaborative arrangements).
 - How the quality and extent of institutional support are appropriate for the proposed research.
- **Budget**
 - Whether the budget is appropriate for the proposed research and within the limitations of this Program Announcement/Funding Opportunity.
- **Application Presentation**
 - To what extent the writing, clarity, and presentation of the application components influenced the review.

2. Programmatic Review: To determine the application's relevance to the mission of the DoD and BMFRP, as well as to make funding recommendations, the following equally considered criteria are used by programmatic reviewers:

- Adherence to the intent of the award mechanism
- Programmatic relevance to the FY12 BMFRP objectives
- Program portfolio composition
- Ratings and evaluations of the peer reviewers
- Relative impact and innovation

C. Recipient Qualification

Refer to the General Application Instructions, Appendix 1, for additional information on organization and Government agency requirements.

D. Application Review Dates

All application review dates and times are indicated on the [title page](#) of this Program Announcement/Funding Opportunity.

E. Notification of Application Review Results

Each PI and organization will receive notification of the funding recommendation. Each PI will receive a scientific peer review summary statement on the strengths and weaknesses of the application.

IV. ADMINISTRATIVE ACTIONS

After receipt of pre-applications from CDMRP eReceipt or applications from Grants.gov, the following administrative actions may occur:

A. Rejection

The following will result in administrative rejection of the pre-application:

- Preproposal Narrative exceeds page limit.
- Preproposal Narrative is missing.

The following will result in administrative rejection of the application:

- Project Narrative exceeds page limit.
- Project Narrative is missing.
- Budget is missing.
- Submission of the same research project to different funding opportunities within the same program and fiscal year.
- Submission of an application for which a letter of invitation was not received.

B. Modification

- Pages exceeding the specified limits will be removed prior to review for all documents other than the Project Narrative and Preproposal Narrative.
- Documents not requested will be removed.
- Following the application deadline, the PI may be contacted by CDMRP via email with a request to provide certain missing supporting documents (excluding those listed in Section IV.A., Rejection). The missing documents must be provided by 5:00 p.m. ET on the second full business day following the date the email was sent. Otherwise, the application will be reviewed as submitted.

C. Withdrawal

The following may result in administrative withdrawal of the pre-application or application:

- A FY12 BMFRP IP member is named as being involved in the research proposed or is found to have assisted in the pre-application or application processes including, but not limited to, concept design, application development, budget preparation, and the development of any supporting document. A list of the FY12 BMFRP IP members can be found at <http://cdmrp.army.mil/bmfrp/panels/panels12.shtml>.
- The application does not conform to this Program Announcement/Funding Opportunity description to an extent that precludes appropriate review.
- Direct costs as shown on the Research & Related Budget exceed the maximum allowed by this Program Announcement/Funding Opportunity.
- Inclusion of URLs, with the exception of links in References Cited and Publication and/or Patent Abstract sections.
- Page size is larger than 8.5 inches x 11.0 inches (approximately 21.59 cm x 27.94 cm).
- Inclusion of any employee of CDMRP review contractors in applications for funding without adequate plans to mitigate conflicts of interest. Refer to the General Application Instructions, Section II.B., for detailed information.
- The proposed research is, or requests funding for, a clinical trial.
- The PI does not meet the eligibility criteria.

D. Withhold

Applications that appear to involve research misconduct will be administratively withheld from further consideration pending institutional investigation. The institution will be required to provide the findings of the investigation to the USAMRAA Contracting/Grants Officer for a determination of the final disposition of the application.
